*In the **Trent River Watershed** and **Anderson Lake** in the Mt. Washington area*

- ✓ *Serious Water Pollution in:  
Baynes Sound  
Ground and Surface Water  
Drinking Water*
- ✓ *Tsable River and Cowie Creek Watersheds at risk*
- ✓ *Devastation and complete loss of Fish and Shellfish Industries*
- ✓ *Loss of over 500 Jobs in shellfish industry*
- ✓ *Earth Quake and Tsunami impact risks*
- ✓ *Adverse affects to Human Health (air and water quality)*
- ✓ *Disturbed Wildlife Corridors*
- ✓ *No clean up and restoration as result of early closure, accident or Bankruptcy*

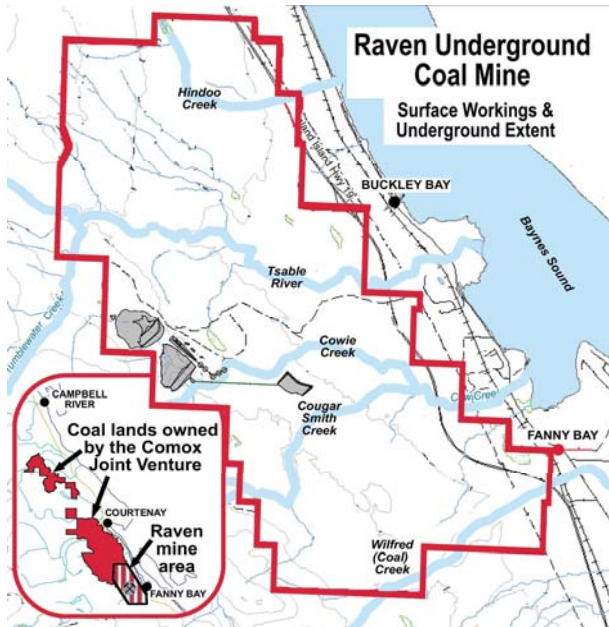
